## **Guest Speakers**

We are extremely pleased to have joining us this year, guest presenters from two states that are leading the nation around the issue of growth screening in schools.

Joy C. Rockenbach is the Program Director of the Body Mass Index Initiative at Arkansas Center for Health Improvement (ACHI). In 2003 the Arkansas General Assembly and Governor Mike Huckabee passed Act 1220. This Act represented the first statewide multifaceted approach to engage, inform and activate parents, schools and community leaders about the issue of childhood obesity specifically in the state's public school system. Upon request by the Arkansas Departments of Education, ACHI staff was charged with developing, implementing and tracking standardized statewide BMI assessments and reporting. In an unprecedented way, the State of Arkansas can now accurately detail the obesity epidemic and parents now have new and critically important health information about their children. Through summary reports to schools, Arkansas's teachers, schools, doctors, nurses and communities are now aware of the problem. ACHI will share their challenges, process, outcomes and materials.

Allison Topper is the Executive Director of the Pennsylvania Advocates for Nutrition and Activity (PANA). PANA is a statewide, nonprofit organization supported by a coalition of more than 500 public, private, academic, professionaland volunteer groups, working to promote policies and environments that support healthy eating and activity. State Health offices have teamed with PANA to implement its new Pa. Growth Screening Program.


As it has in the past 50 years, the State Department of Health (PADOH) requires schools to weight and measure students, but a revised growth-screening initiative was introduced for 2005-2006 by state Health Secretary Dr. Calvin B. Johnson. PANA has been working to implement the program, specifically by furnishing school nurses and other personnel with screening kits. The kits help schools communicate with parents and students about weight related issues. Joining Allison will be Beth Anne Bahn, State School Health Consultant, from the Division of School Health. The Division housed in the Bureau of Community Health Systems monitors and evaluates school districts' compliance with State laws, regulations, and policies; provides consultation and technical assistance to districts to support and improve health programs and services; develops policy, procedures, guidelines and adopts records and report forms to support and facilitate the efficient operation, administration and evaluation of the school health program; and fosters state and local cooperation and coordination of programs and services. Allison and Beth Anne will be sharing Pennsylvania's screening kits, protocols and experience.
