- Log on to U-Online
- Select Student Services Menu
- Select Student Records
- Select Request Printed/Official Transcript
  - Follow the Prompts
- Click Submit Request (the request will then be put into the queue to be printed in the Registrar's Office)

#### IMPORTANT

Dear Faculty& Staff,

To be in compliance with reporting regulations: Starting this current Fall 2016 semester, the Registrar's Office will now be reporting student enrollment status differently to the National Student Clearinghouse (NSC). *This will only affect students whose enrollment statuses dip below fulltime when withdrawing from a class(es). If a student withdraws from a class(es), but their credits still indicate fulltime in their program/major, then no changes will occur.* To know what defines fulltime enrollment status for your program/major click <u>HERE</u>

How this affects your student advisees:

- 1. It could impact eligibility to participate in intercollegiate athletics
- 2. It could impact eligibility for Veteran's benefits.
- 3. A Withdrawal from a course(s) at any point after the Add/ Drop period will be reported to the NSC. A withdrawal which changes a student's enrollment status could impact re-payment of loans/deferment of loans.
