<p>Are there services covered before you meet your <u>deductible</u>?</p>	<p>Yes: <u>In-Network durable medical equipment</u>, <u>emergency room care</u>, <u>emergency medical transportation</u>, prescription drugs, outpatient mental health services, <u>preventive care</u>, <u>provider</u> office visits, <u>rehabilitation services</u>, <u>habilitation services</u>, routine eye exams, are covered before you meet your <u>deductibles</u>.</p>	<p>This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount.
